Nomination Process:

As a minimum, candidates for election as Board members are required to:

- Have experience with the governance of a not for profit, or willingness to learn.
- Demonstrate commitment to AOT's purpose to make a positive difference to the lives of Tasmanians affected by arthritis, osteoporosis and related musculoskeletal conditions.
- Be prepared to commit and participate (that is, attend a Board meeting every second month (for approximately 2 hours), with additional time to review agenda papers and prepare to contribute.
- Maintain financial membership of AOT throughout their tenure.

The Board particularly encourage nominations from candidates with the following specific knowledge, skills and experience:

- Financial and accounting skills.
- Marketing and communications expertise.
- Commercial/business acumen.
- Advocacy strategy skills and experience.
- Lived experience with arthritis and/or associated musculoskeletal condition/s.
- Medical/allied health professional service delivery experience.
